## From the Chair

# 2012 was an intense year for women and girls here in this country and around the

world. From the brave 15 year old Pakistani schoolgirl who was shot on the bus on her way to school for daring to be an outspoken advocate of education for girls, to the "war on women" that arose around the election, we were reminded of what is at stake. And how vital all of our voices and actions are to counter the injustices that face women and girls.

Here at the Valentine Foundation, we think global and largely act local. In order to create genuine social change for women and girls, attitudes, definitions, levels of engagement, and policies have to shift (or in some cases, be maintained). Valentine focuses its grantmaking on organizations and programs that are strategically focused on creating those shifts. In 2012, the Foundation awarded \$142,500 to 14 organizations that are committed to creating lasting social change for women and girls. These nonprofits are committed to powerful social shifts — focusing

their attention on immigrant and migrant women, incarcerated women, trafficked women and girls, access to abortions, safe and healthy families, amplifying the voice of a poet and activist (and Philadelphia treasure), and other efforts that will impact the lives of so many right here in the Philadelphia area.

As a complement to the Foundation grants, the Valentine Fund for Visionary Leadership provides funding for leadership training for women executives of nonprofits that improve the lives of women and girls in the Greater Philadelphia region. The Fund was created to make current women leaders more effective, develop the next generation of women leaders, and foster a community of women leaders. **This year, the Fund awarded** \$12,900 to support the leadership development efforts of three women.

You'll see a listing of all the grantees in this report, and I encourage you to visit our website to learn more about the organizations and the important work that they're doing to improve the lives of so many women and girls. May they inspire you as they do us.

It's been said that when you help a woman, you impact a family, transform a community and change the world. I think I speak for all of us at the Valentine Foundation when I say that it's a profound honor to play a small part in changing our world.
